By signature of the Application for Distribution of funds we also confirm that by moment of Distribution of the Quotient in compliance with this Application:

- we relieve the Trustee of the TRUST from all liabilities which Trustee of the TRUST has towards the Beneficiary in respect to effecting the Distribution;
- we waive claiming of all actions, claims or proceedings whatever nature suited based on or in connection with performed Distribution to the Beneficiary based on this Application
